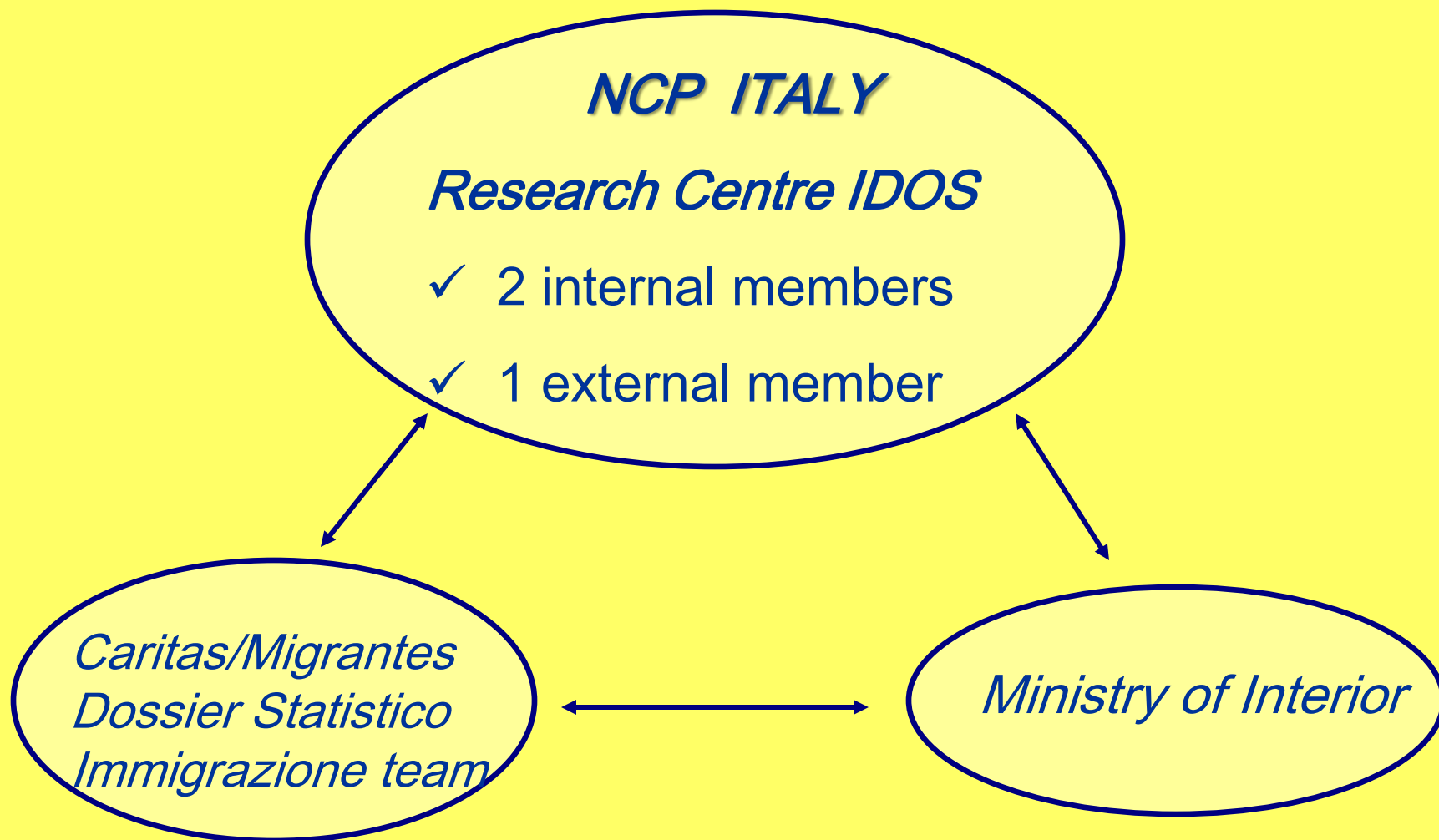

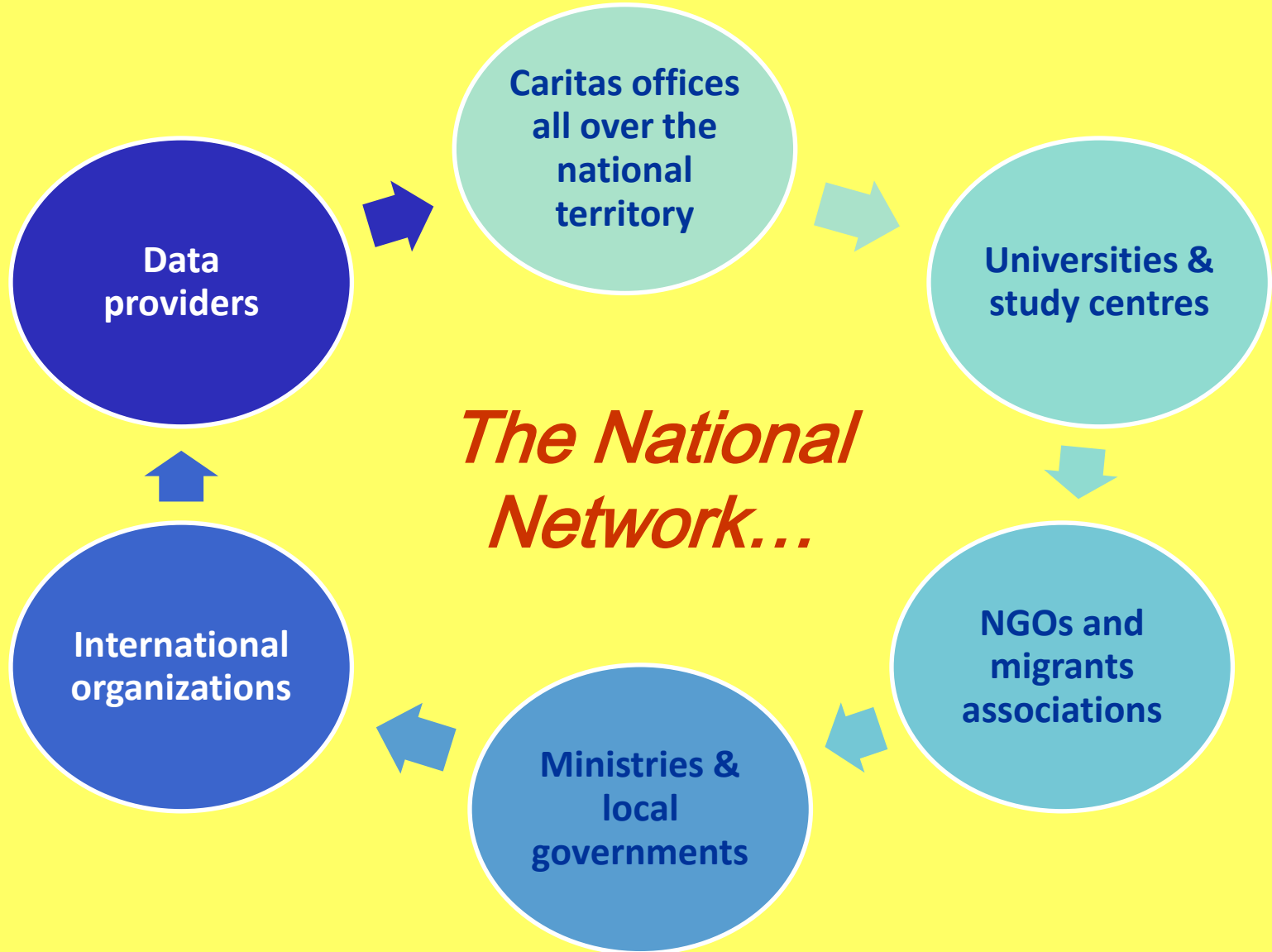

How was the national network established?

The Italian NCP could take advantage of the existing network built by the Caritas/Migrantes *Dossier Statistico Immigrazione*.

During these 5 years of the project this existing structure grew up through:

- ✓ the more general sensitization activity organized by the Caritas/Migrantes *Dossier Statistico Immigrazione*
- ✓ events specifically organized in the framework of the project in cooperation with the Ministry of Interior

The future...

How to develop the national network?

- ✓ at least 2 national meetings per year
- ✓ involvement in research activities
- ✓ sensitization events and ad hoc presentations
- ✓ involvement of national partners in international activities and *vice versa*
- ✓ website → newsletters → visibility

Meetings with the national network

- ✓ 2005-2007: 5 meetings (3 Rome, Kroton and Bari)
- ✓ Structure of meetings: update on EMN activities, new partners' involvement, empowerment of the network, etc.

Research activities

- ✓ involvement of the national experts in the preparation of the EMN studies (IOM Rome, Universities, Censis, etc.)
- ✓ creation of ad hoc scientific committees for the evaluation of the researches (i.e., SSS on health sector)

Sensitization events and ad hoc presentation

- ✓ involvement in the events organized by the Caritas/Migrantes *Dossier* (at least 200 every year)
- ✓ ad hoc events organized in the EMN framework (i.e., presentation of *Return Migration* study on May 7, 2007)

Links between the national network and the European Commission and the EMN NCPs

- ✓ **twinnings & study visits** (Poland, Austria, Hungary, Greece, Slovenia and for 2008 again Hungary and Greece)
- ✓ **visits in Italy** of Austria, the Netherlands and Greece NCPs and at the end of October 2008 Hungary, Greece and Estonia
- ✓ **involvement of national partners in international events** (i.e., enlarged meetings & final conferences)
- ✓ **participation of the EMN partners to national events** (i.e. hosting in Rome a Thesaurus Meeting in Oct. 2005)

A study visit in Hungary

Visit to a Reception Centre and meeting with the Hungarian Ministry of Interior

On November 10th and 11th the Italian and Hungarian NCPs organized a study visit in Budapest, Hungary as part of the activities of the EMN-European Migration Network for the year 2005.

This study visit involved representatives of the EU Co-operation Office within the Hungarian Ministry of the Interior and three contact persons of the Italian NCP. In order to extend participation to some members of the Italian National Network, representatives of the Dossier Statistico Immigrazione team, Fondazione Migrantes and the regional network of researchers who write for the annual Dossier, attended the study visit.

The initiative, which was developed to promote the exchange of opinions and experiences within the field of migration and asylum between the representatives of the two countries, was organized with the following agenda:

In the morning arrival in Budapest and transfer to Bicske to visit the Reception Centre for refugees and asylum seekers in the afternoon. The Italian delegation was provided with information on how the Centre is organized and the procedures used to access its services.

The day was concluded with an informal dinner among representatives from the two countries.
